Program Activities

AZCC serves youth, aged 15 to 18 and young adults, aged 18 to 25, who are interested in environmental, resource conservation and land management related careers. Through direct, hands-on service, AZCC Corpsmembers implement projects for virtually all of Arizona's public land managers and conservation agencies. Each AZCC Corpsmember receives extensive work-skills training and conservation education in addition to service learning and AmeriCorps Education Awards that directly benefit their future pursuits in environmental fields.

Project work helps to protect rural communities throughout Arizona from the threat of wildfire; increases habitat for, and the populations of a variety of wildlife species; and provides greater, less damaging recreational opportunities for Arizona's citizens and visitors.

Community Need

Based on the Corps model used successfully throughout the US for more than 75 years to address critical environmental and infrastructure needs, AZCC has been providing youth and young adult workforce development opportunities and natural and cultural resource conservation services in collaboration with a wide variety of community partners since 1997. The community needs we have identified are to provide meaningful job skills and personal developmental opportunities for youth and young adults and to improve overall forest health.

National Priority Area and Program Performance Goals

61 Corpsmembers aged 18 to 25 receive on the job work skills, mobilize community volunteers and engage in leadership training through implementation of projects helping to protect communities from wildfire and improve overall forest health.
